Following an investigation, it was identified that this was due to sudden changes in the composition of the waste being processed. The Environment Agency (EA) were informed.

Other notes

- On 9th and 26th September, Line 2 experienced a blockage to the ash conveyor, this saw the ERF stop processing waste for a number of hours and resulted in no daily average. The ERF resumed processing waste shortly afterwards.
- On 13th and 14th Line 1 stopped processing waste for a number of hours following a blockage within the flue gas treatment facility.
- Line 1 experienced a blockage in the ash discharge system in the late morning of 19th. The line was brought off-line in accordance with the Permit to enable the blockage to be removed resulting in no daily average. Line 1 was brought back into full operation just after midnight on the 20th.



Reporting of Continuously Monitored Emissions to Air for CO mg/m3 at Emission Point A2 For the month of September 2024



Reporting of Continuously Monitored Emissions to Air for CO mg/m3 at Emission Point A1 For the month of September 2024



Installation: Beddington Reporting of Continuously Monitored Emissions to Air for Particulates mg/m3 at Emission Point A1 For the month of September 2024





Reporting of Continuously Monitored Emissions to Air for VOC mg/m3 at Emission Point A1 For the month of September 2024





Reporting of Continuously Monitored Emissions to Air for VOC mg/m3 at Emission Point A2 For the month of September 2024





Reporting of Continuously Monitored Emissions to Air for HCl mg/m3 at Emission Point A1 For the month of September 2024



Reporting of Continuously Monitored Emissions to Air for HCI mg/m3 at Emission Point A2 For the month of September 2024





Reporting of Continuously Monitored Emissions to Air for SO2 mg/m3 at Emission Point A1 For the month of September 2024



Reporting of Continuously Monitored Emissions to Air for SO2 mg/m3 at Emission Point A2 For the month of September 2024





Reporting of Continuously Monitored Emissions to Air for NH3 mg/m3 at Emission Point A1 For the month of September 2024



Reporting of Continuously Monitored Emissions to Air for NOx mg/m3 at Emission Point A2 For the month of September 2024


